Anesthesiologists may not be aware of recent developments to improve feasibility and rigor of clinical research projects.

Needs that Underlie the Gap

Gap in latest evidence to guide best practice in perioperative cardiovascular medicine. Gaps in performance of impactful cardiovascular outcomes research and securing protected time and research funding to conduct research.

A lack of consensus regarding best practice standards can result from apparently conflicting evidence in the field and can result in a barrier affecting patient outcomes. The symposium will lower this barrier by improving the learners understanding of the best evidence for practice. The physicians in attendance will be able to deliver a higher quality of care in perioperative medicine and

research by reviewing evidence-based material that has been identified as a professional practice gap. Teaching modalities will include panel discussions, Q&A sessions, and presentations.

DESIGNED to Change/Outcome: Following this activity, learners will develop competence by increasing their knowledge through a combination of hands-on learning, case-based presentations, and online lectures. Knowledge will be assessed with a pre-test and post-test.

The combination of in-person demonstrations, didactic lectures, case-based panel discussions and clinical dilemmas which demonstrate the broad clinical utility of perioperative echocardiography, participants will be able to improve on all the competencies mentioned above by gaining knowledge on new practice guidelines and new technologies, as well as observing and participating at discussions in multidisciplinary panels with case -based presentations.

Educational Objectives

After completing this activity, the participant should be better able to:

- Describe the latest advances and research in perioperative cardiovascular medicine.
- Identify current trends in clinical and bench research pertinent to the perioperative care of patients.
